Minutes of Meeting

November 26, 2019

Meeting called to order by Committee Chair Randall Henderson at 18:10 hrs at the Seaside City Hall.

Review of Minutes: Dianne Widdop makes a motion to approve September minutes as presented, Joyce Hunt seconds, motion passed.

Infrastructure / Improvements: Report from Dale McDowell via Randall Henderson that the PMP still needs to be done, crack seal all and re-mark pavement has been delayed to 2020. No other grants in the works.

Airport Funding: Nothing new. To become a rolling agenda item for new projects if and when.

Port of Astoria News: Bruce Francis to get on the Port of Astoria agenda to see about the Port sponsoring a crew car.

Maintenance, Safety and Security: Auto & pedestrian gates working good. Golf balls still being found on the airport including the runway, most likely coming from the Mobile Home Park. Also Park residence dumping grass clippings on the airport side of the fence. Dale McDowell sent a letter to the Mobile Park Management about concerns, no response. Possible signs with some strong FAA wording to discourage activity. City and the hangar tenants are volunteering to help with the mowing to keep airport looking nice. Pilot Controlled Lighting to be available 24/7 bypassing the photo cell.

Promotion & Services: City making headway on getting internet to all City facilities, could be a few more months before available at the Airport. Randall Henderson to promote new weather station and cameras to EAA chapters, etc. Info on Facebook, Northwest flyers. Good feedback on visitor log about bikes. FAA require flood plain survey for bike shed. Dale McDowell working on getting said survey. Go Fund Me account for bike shed around \$2000.00. Randall Henderson and Teri Carpenter working on getting a usage count from data collected from the trail cams mounted on the windsock pole.

Commercial Operations: Some interest in additional hanger space, need 5 more aircraft based in Seaside to be reclassified.

Committee Member Comments: None.

For the Good of the Order: Non habitable structures fall under a different set of guidelines for flood plains.
